2016 AFL Umpire FootyWeb Promotion

TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents who are eligible to register as an Australian Football umpire on the FootyWeb platform at <u>https://reg.foxsportspulse.com/</u> ("the Website") excluding umpires listed to officiate at official AFL games of the 2016 Toyota AFL Premiership Season. Persons entering the Competition who are under 18 years of age require their parent's or legal guardian's permission ("Eligible Entrants").
- 3. Employees (and their immediate families) of the Promoter and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, exspouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, step-sister or 1st cousin.

- 5. To enter, Eligible Entrants must have registered as an Australian Football umpire on the Website to umpire in Australian Football games in the 2016 season by 11.59pm on 31 July 2016.
- 6. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, whether he/she is a qualified Australian rules football umpire for games in the 2016 season, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

- 9. The first valid entry drawn will win two (2) tickets to the 2016 Toyota AFL Grand Final as provided by the Promoter to be held on Saturday, 1 October 2016. The prize is for the tickets only and does not include any travel or other costs. Any costs or expenses associated with attending the match are the responsibility of the winner and any companion.

By entering this Promotion, each entrant requests that his or her full address not be published.
