Terms and Conditions

1. The Promoter and Executor of this program is Carlton Football Club, ABN 95 005 449 909 ("CFC")
2. Participation in this promotion is deemed acceptance of these Terms and Conditions. Information on how to enter and prizes form part of these Terms and Conditions.
3. To be eligible to enter, members must donate a minimum of \$200 to the Carlton Football Club during the Promotional Period. For every \$200 donation, the member will receive a collectable card and 1 entry into the draw. Each collectable card has a unique entry number which will be used to identify the Grand Prize Draw winners.
