WIN an i30 Active Auto Conditions of Entry

A. General

1. Information on how to enter this Promotion, mechanics of entry and prizes form part of these Conditions of Entry. Entry into this Promotion is deemed acceptance of these Conditions of Entry by each Entrant.
2. Entry is open to every attendee in their seat at the Round 22 Carlton v Hawthorn game at Etihad Stadium on Saturday 19 August 2017 at half time (**Entrants**). The Promoter is Carlton Football Club Limited (ABN 95 005 449 909) of IKON Park, 400 Royal Parade, Carlton North, Victoria 3054.
3. The directors, officers, management and employees (and their immediate families) of the Promoter and its related bodies corporate are not eligible to enter this Promotion.
4. The Promotion commences at 07:25PM on 19 August 2017 and ends at 10:00PM on 19 August 2017.**(Promotion Period)**.

B. Entry

5. Entrants will be automatically entered into the Promotion when they purchase a ticket to the Round 22 Carlton v Hawthorn game. Entrants must be at the stadium and in their seat at the time the draw is conducted to be eligible for the Promotion.
6. There is a limit of one entry per person for the duration of the Promotion Period.
7. Entries will be deemed accepted at the time of receipt by the Promoter and not at the time of transmission. Entries received will be considered final by the Promoter. C. Drawing Winners

9. The draw will be conducted on Saturday 19 August at three quarter time approximately 9:00PM (AEST) at Etihad Stadium, 740 Bourke Street, Docklands VIC 3008.
10. An entire row will be selected, and each person in their allocated seat will be deemed a finalist. The finalists will be announced in stadium via big screen visuals as well as audio over the loud speakers after 9:00PM AEST on 19 August 2017.
11. The finalists will be invited to the level two stage area of Etihad Stadium at three quarter time, approximately 9:00PM, where they will take part in a draw to win first prize, an i30 Active Auto and second prize, a return trip for two to Hawaii. The winners will be announced in stadium via big screen visuals as well as audio over the loud speakers after 09:00PM AEST on 19 August 2017.
12. The Winner will be notified after 09:00PM AEST on 19 August directly by Carlton Football Club staff where further contact information and details will be requested including, but not limited to, full name, phone, email, and address. Due to the nature of the LED signage, a random draw will take place at Carlton Football Club Limited, IKON Park, 400 Royal Parade, Carlton North, Victoria 3054 to predetermine within which level the winning aisle and row will be drawn.
13. The name and state of a Winner may be published on Carlton Football Club various social media channels, as well as members' electronic marketing newsletters, and local newspapers after 19 August 2017.

14. If the prize is not claimed in the stadium at three quarter time, a redraw will be conducted. If required, the redraw will be conducted momentarily on 19 August 2017 at 09:10PM AEST at Etihad Stadium, 740 Bourke Street, Docklands VIC 3008.
15. A redrawn Winner will be notified as per clauses.13 and 14. directly after the redraw. The name and address of the re-draw Winner may be published on Carlton Football Club various social media channels, as well as members' electronic marketing newsletters, and local newspapers after 19 August 2017.
16. Entries not fully complying with these Conditions of Entry may be deemed invalid at the Promoter's discretion. D. First Prize

G. Intellectual Property

34. If this Promotion requires an Entrant to create any written material, imagery or sound recordings, the provisions in this Section F apply.
35. As a condition of entering this Promotion, the Entrant warrants to the Promoter that:

36. If for any reason this Promotion is not capable of running as planned, including due to infection by computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this Promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available and to cancel, terminate, modify or suspend the Promotion, or invalidate any affected entries, subject to any written direction given under State Regulation.
48. Nothing in these terms and conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Promotion and Consumer Act 2010 (Cth), as well as any other implied warranties under the ASIC Act 2001 (Cth) in Australia, or similar consumer protection laws in the State and Territories of Australia (**Non-Excludable Guarantees**). The Promoter and its associated agencies and companies (and their respective officers, employees and agents) exclude all liability (including negligence) except for any liability that cannot be excluded by law, including the Non-Excludable Guarantees, for any direct, indirect or consequential injury, loss and/or damage arising in any way in connection with this Promotion or any prize/s. failure, internet failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.

51. The Promoter is not liable for any tax implications arising from prize winnings. Independent financial advice should be sought as tax implications may arise as a result of accepting the prize.
