

1. Instructions, prizes and information on how to enter form part of these conditions of entry. By participating, entrants accept these conditions of entry.

2. The Promoter is Antler Luggage Australia Pty Ltd (ABN 14 007 047 627) of 72-76 Western Ave, Westmeadows VIC 3049.

3. EACH ENTRANT AGREES TO ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY/ALL ACTIVITIES ASSOCIATED WITH THIS EVENT, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault. Each entrant consents to receiving medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.

Each entrant understands while participating in this activity, I may be photographed or videotaped. Each entrant agrees to allow their photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

The Accident Waiver and Release of Liability above shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

4. The total promotional period begins at quarter time at the Essendon v Richmond match

at MCG Stadium on 29 August 2015 and concludes at 8pm EST on 29 August 2015.

5. Entries are open to all attendees over the age of 18 at the Essendon v Richmond match at MCG Stadium on 29 August 2015 excluding the following:

- Employees, directors, management, licensees and contractors of the AFL, Essendon Football Club or Richmond Football Club and the Promoter and their related companies and agencies associated with the Promotion and the immediate families of the listed persons;
- Any current or former AFL, NRL, ARU, FA or equivalent level professional players;
- Any current VFL or equivalent level League grade players and any who have played in these competitions in the past 5 years;
- Any current VFL or equivalent level Reserves grade players and any who have played in these competitions in the past 2 years;
- Any current VFL or equivalent level TAC (under 18's) grade players and any who have played in these competitions in the past 1 year; or
- Any current State 18's or State 16's AFL, VFL or equivalent TAC Cup players

6. The prize is the chance to enter the 'Antler Kick for Cash' promotion. To win the prize of \$20,000 you will be required to kick a full sized regulation Australian Rules football (inflated to the manufacturer's standard recommended pressure) from the 50m line and hit the Antler suitcase placed at the top line of the goal square on a 1m pedestal.

7. To enter this competition, eligible entrants must be an attendee at the Essendon v Richmond match at MCG Stadium and be a supporter of the Essendon Football Club or the Richmond Football Club. 8. The Promoter will randomly select two entrants from each of the Essendon Football Club and the Richmond Football Club who are seated in their respective member's bays at 6:30pm at the Essendon v Richmond match at MCG Stadium on 29 August 2015. The entrant will be given until 8:00pm on 29 August 2015 to claim the entry to attempt the 'Antler Kick for Cash".

9. Each entrant will be given one kick only. No practice attempts allowed.

10. The kick will be taken as a standard Australian Rules Football style drop-punt and must hit the target on the full. The flight of the ball must leave the contestants foot and fly directly and uninterrupted at the Antler suitcase without touching the ground, and without touching any other object, and knock the Antler suitcase completely off the pedestal in order to be considered a successful shot.

11. There will be one prize only and in the event both entrants hit the target, the prize will be shared equally between them.

12. The individuals selected in the draw must be the same individuals that participate in the competition. Persons selected are not allowed to appoint another person to take the kick on their behalf.

13. The Promoter may conduct such further draws to find the necessary entrant to take the kick. If the winner cannot take the kick as stipulated or it is unclaimed, the entry will be deemed invalid and the Promoter reserves the right to conduct further draws and award entry the kick to another randomly selected entrant.
