

# Schedule for the 2017 GMHBA Family Health Challenge

## Promotion 2017 GMHBA Family Health Challenge.

**Promoter** The Promotion will be conducted by the **Geelong Football Club Limited (ABN 67 005 150 818)** of Simonds

Stadium, Kardinia Park, La Trobe Terrace, Geelong, Victoria, 3220 ("the **GFC**").

### Entry Restrictions

- a) Entry is open to Australian residents, living in Victoria.
- b) All minors (entrants under the age of 18 years), must have parental or guardian (being a person aged 18 years or older) consent to participate in this Promotion and any prize event at the commencement of the Entry Period, and at the time of winning in order to be eligible to redeem any prize.

### Method of Entry & Conditions

- (a) Entry is open to persons who receive notification of this Promotion and satisfy the eligibility criteria during the Promotional Period (Entrants). This promotion is not available with other offers. Employees and their immediate families of the Promoter and its agencies associated with this promotion are ineligible to enter.

The Promoter's decision is final and no correspondence will be entered into. Only one (1) entry per person is permitted. The Promoter reserves the right to disqualify an entry and any such decision to disqualify an entry is final and no correspondence will be entered into.

Maximum number of participants per family is 4. Must include 2 adults and 2 children aged between 5 and 18.
- (h) The winner and their family must be available on the above mentioned day prior to the game. Winners and their family must, at their own cost, make their own way to Simonds Stadium.
- (i) Each prize is valued at \$656 + GST. Total prize pool is \$1968 + GST.

- (j) No monetary value can be determined for the pre-match activity. Unless otherwise stated the prize or portions of prizes are not transferable, cannot be sold and no prizes may be taken as cash. Promoter accepts no responsibility for any variation in the value of the prizes. Supplier's terms and conditions apply. The pre-match activity will involve, but not be limited to: Each family member will be required to complete an obstacle course featuring agility sticks, tackle bag, and handball target. Four reserved seats to the Geelong Cats v Sydney Swans game on Friday 4 August, 7.20pm. Four customised team uniforms includes 1 x tracksuit pant each and 1 x tracksuit top each. In order for the winners and their family to participate in the activity, at Simonds Stadium, each participant must fully complete and sign an indemnity waiver and release form each. Should a participant be under the age of 18, a parent or guardian will need to sign the form on their behalf. Failing to do so will result in non-participation.
- (k) The winner will be notified via email and phone no later than 5:00pm Wednesday 26<sup>th</sup> July 2017. In the event that for any reason whatsoever the winner does not take an element of the prize then that element of the prize will be forfeited by the winner and another winner will be drawn. Where the prize remains unclaimed, the Promoter may award the prize to the second chosen entry (Alternative winner) in order to award the prize. The Alternative Winner of any such unclaimed prize will be notified by email no later than 5:00pm Friday 28<sup>th</sup> July 2017.
