TERMS AND CONDITIONS

Hawthorn Football Club's #TrueColours Instagram Competition

1. General

- a. Entry into the #TrueColours Instagram Competition constitutes acceptance of these Terms and Conditions.
- b. Information on how to enter forms part of these conditions.
- c. The Promoter is Hawthorn Football Club, Ricoh Centre, 3/2 Stadium Circuit, Mulgrave VIC 3170. ABN 26 005 068 851 (The Promoter).
- d. For the purposes of the Terms and Conditions, Hawthorn Football Club includes all related and subsidiary companies, past, present and future officers, agents, representatives, employees and assigns.

2. Entry Requirements

- a. Entry to the Competition is open to Victorian residents. Entrants under 18 years of age need to have the consent of their parent or guardian to enter the Competition. Employees of The Promoter and their immediate families are not eligible to enter the Competition.

The Promoter shall not be liable for any loss or damage whatsoever that is suffered by any entrant (including but not limited to indirect or consequential loss), or for any personal injury suffered or sustained as a result of taking any judging, except for the liability that cannot be excluded by law.

4. Prizes
