MELBOURNE FOOTBALL CLUB LIMITED 'ROBBO'S 2015 SCRATCH AND WIN' PROMOTION

TERMS AND CONDITIONS

- 1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Promotion is offered to members of the Melbourne Football Club, aged 18 years and over.
- 3. The Promoter reserves the right, at any time, to verify the validity of entries/claims and to disqualify any entrant who tampers with the entry/claims process or who submits an entry/claim that is not in accordance with these Terms and Conditions.
