4. By entering this Competition, you agree to hold harmless the Promoter in respect of the general running and management of the Competition and any aspect of the Prize and the Promoter will not be liable for any claim, loss or damage in this respect.
5. The Club Sponsor Competition (**Competition**) commences at 9:00am AEST on 08/08/2017 and closes at 5:00pm AEST on 16/08/17 (**Promotion Period**). Neither the Promoter or the Sponsor take any responsibility for late, lost or misdirected entries due to trade disruptions, human error, or for any other reason. Incomplete, illegible or incomprehensible entries will be deemed invalid.
