"BE DRIVEN TO FAN DAY THANKS TO VOLKSWAGEN" PROMOTION

TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Subject to clause 4, entry is only open to Australian residents who are available to attend either of the following two events:
