

## CONDITIONS OF ENTRY

For the comfort, safety and enjoyment of all patrons, staff and event participants and/or pursuant to the Major Sporting Events (Crowd Management) Act 2009 (Victoria) please note the following Conditions of Entry in relation to persons' use and entry to Arden Street Oval (Venue) which is operated by North Melbourne Football Club in conjunction with the City of Melbourne.

1. Management reserves the right to refuse entry to any persons.
2. Concession patrons must show a valid identification card as proof of eligibility at the ticket box and at the turnstile.
3. Management reserves the right to manage patron access to the Venue via screening equipment/checks.
4. Patrons must comply with any request for electronic and/or personal body searching.
5. Management reserves the right to inspect any bag and/or articles of clothing for the following prohibited items:
  - alcohol
  - illegal substances including controlled, dangerous or illicit drugs
  - opened drink containers
  - cans/glass
  - musical instruments
  - whistles
  - unauthorised temporary signage and promotional products
  - flags/banners with handles exceeding 1.6 metres
  - fireworks/flares/laser lights/smoke generators
  - firearms, explosives, chemical, radioactive or biological substances
  - chairs/stools
  - rollerblades/skates, skateboards, scooters or bicycles
  - animals (other than guide/assistance dogs)
  - professional cameras, audio recording equipment, video cameras or tripods
  - any large item that will impede other patrons viewing
  - any other item that in the opinion of management could cause harm or public nuisance
6. The carriage and operation of drones (or any such aircraft) is prohibited.

7. Prams, pushers, eskies, bags and other belongings are permitted into the Venue
8. Alcoholic beverages must not be taken into or from the Venue.
9. Alcohol may only be consumed in designated areas.
10. The Venue is a smoke-free venue – smoking (including the use of e-cigarettes) is not permitted within the venue or in the designated smoke-free areas outside.
11. Tickets must be retained at all times.
12. Pass outs will not be issued.
13. Any tickets that are damaged, defaced or have been purchased from an unauthorised agent will not permit the holder to be admitted to the Venue.
14. Patrons may be filmed/photographed.
15. By entering the Venue patrons consent to their image, likeness or voice being captured and used as part of any recording of the event or any other purposes.
16. Patrons may be liable for prosecution, fined or ejected from the Venue if they:
  - have entered the Venue and/or the arena without prior authorisation;
  - are deemed by management to be displaying disorderly, offensive or unlawful behaviour;
  - use foul or abusive language, or make racial or threatening remarks or gestures; or
  - fail to comply with any of these Conditions of Entry or requests from Venue staff or their representatives.
17. No ticket refund will be paid to patrons ejected from the Venue.
18. Patrons under the age of 12 years must be accompanied by a parent or guardian at all times within the Venue.
19. Patrons are admitted to the Venue at their own risk. The Venue will not be held responsible for any damages to, loss or theft of a patron's personal property nor for any other loss, damage or injury suffered by any patron, whether in contract, tort or statutory liability to the full extent permitted by law.
20. In addition to the above, the Venue may exercise any rights granted under the Major Sporting Events Act 2009 (Vic) or other legislation or regulations pertaining to the Venue.
