

## TERMS AND CONDITIONS OF ENTRY INTO "2016 Sydney Swans Junior Mascot Competition by Citi"

1. Information on how to enter and prize details form part of these terms and conditions; however, to the extent that there is any inconsistency between these terms and conditions and any other published material, these terms and conditions will prevail. By participating in the "2016 Sydney Swans Junior Mascot Competition by Citi" each participant fully and unconditionally agrees and acknowledges that these terms and conditions are binding.

2. The Promoter is Citigroup Pty Limited ABN 88 004 325 080 of 2 Park Street, Sydney NSW 2000 ("Citi" or "the Promoter"), tel: 13 24 84. The Promoter and its related bodies corporate (as that term is defined in the Corporations Act 2001 (Cth)) will be known as "Citigroup".

3. "2016 Sydney Swans Junior Mascot Competition by Citi" consists of three (3) promotional periods with the overall promotion period commencing 13 May 2016 and closing 14 August 2016, and the following specific promotional periods and draw dates:

(each, a "Promotional Period").

4. Entry is open to residents of Victoria, Australia (Promotional Periods 1 and 2) and Tasmania, Australia (Promotional Period 3) only who are at least 18 years of age and have a valid email address and phone number ("Eligible Entrants"). To enter the competition you must have a child aged 6-12 who is prepared to participate in the prize. The directors, management and employees (and their immediate families) of the Promoter, its related entities, printers, suppliers, providers and agencies who are directly associated with the conduct of this Promotion are ineligible to enter the Promotion.

5. To enter this Promotion, an Eligible Entrant must, within the any of the Promotional Periods listed in Condition 3, visit <http://www.sydneyswans.com.au/citimascot> (the "Promotional Website") and enter their first name, surname, suburb and post code and current and valid e-mail.

6. Only one (1) entry per person permitted per Promotional Period. Any subsequent entry after the first valid entry is received will not be registered. Entries will be deemed accepted at the time of receipt by the Promoter and not at the time of transmission. Entries received will be considered final by the Promoter. Incomplete, inaccurate, erroneous, ineligible or incomprehensible entries will be deemed invalid. The Promoter accepts no responsibility for late, lost or misdirected entries. Contact details entered incorrectly on the promotional

website by an Eligible Entrant will deem an entry invalid.

7. There are three (3) Prizes available to be won across the promotion, with different draw dates as set out above in Condition 3. Prize details are as below:

Promotional Period 1: The right to nominate a child aged 6 – 12 (“the Nominated Child”) to be the Sydney Swans Junior Mascot at Hawthorn v. Sydney Swans on 20 May at the Melbourne Cricket Ground, Melbourne Australia (“the Event”); the Prize includes four (4) tickets to the game (including the tickets required by the Nominated Child and a Parent/Legal Guardian); a Sydney Swans kit including a guernsey, shorts and socks for the Nominated Child to wear for the duration of the prize and may be kept for personal use after the Event has concluded. The Nominated Child must bring their own running shoes or football boots.

Promotional Period 2: The right to nominate a child aged 6 – 12 (“the Nominated Child”) to be the Sydney Swans Junior Mascot at St. Kilda v. Sydney Swans on 13 August at Etihad Stadium, Melbourne Australia (“the Event”); the Prize includes four (4) tickets to the game (including the tickets required by the Nominated Child and a Parent/Legal Guardian); a Sydney Swans kit including a guernsey, shorts and socks for the Nominated Child to wear for the duration of the prize and may be kept for personal use after the Event has concluded. The Nominated Child must bring their own running shoes or football boots.

Promotional Period 3: The right to nominate a child aged 6 – 12 (“the Nominated Child”) to be the Sydney Swans Junior Mascot at North Melbourne v. Sydney Swans on 20 August at Blundstone Arena, Hobart Australia (“the Event”); the Prize includes four (4) tickets to the game (including the tickets required by the Nominated Child and a Parent/Legal Guardian); a Sydney Swans kit including a guernsey, shorts and socks for the Nominated Child to wear for the duration of the prize and may be kept for personal use after the Event has concluded. The Nominated Child must bring their own running shoes or football boots.

8. The total prize pool value is \$1,500. The Promoter takes no responsibility for any variation in the prize/s value. The prize/s is not exchangeable or redeemable for cash. A prize must be taken as offered and cannot be varied. The prize value is the recommended retail price including GST.

9. The prize draws will be conducted as per above table in Condition 3 at the Promoter’s premises. Winners will be determined by way of a random selection from a computer database containing all entries from Eligible Entrants. The Entrant that submitted the first entry drawn for each Promotion Period will receive the corresponding prize (each, a "Winner"). The Promoter will take all reasonable steps to contact the Winners. The Promoter’s decision is final and no correspondence will be entered into.

10. The Winners will be notified by phone and in writing (email). The Promoter will continue to attempt to contact the Winners up until the prize claim deadline outlined in Condition 11 of these terms and conditions. To claim their prize, the Winner must respond to the notification in the manner that will be set out in the notification email and their child must be available (with a parent or guardian) to attend the relevant game.

11. The Promoter reserves the right to draw six (6) additional reserve winners per Promotional Period and record them (in order) in case an invalid entry or entrant is drawn, or the Eligible Entrant is unable to accept or participate in the prize. The person who was drawn must confirm their eligibility to be awarded the prize, and ability to accept and participate in the prize within two (2) days of being successfully notified by the Promoter that they have won, otherwise their entry will be deemed invalid. In the event of an invalid entry or an ineligible entrant, or if the Eligible Entrant is unable to accept the prize or declines to participate in the prize, the prize will be awarded to the first reserve entry drawn. If the prize cannot be awarded to the entrant drawn, the Promoter will continue the process until the prize is awarded.

12. All additional costs not expressly stated, but which may be incurred in acceptance and use of a prize, are the responsibility of the winner. Such additional costs may include, but are not limited to travel and/or

transport to and from the Event, other transfers, accommodation, meals and beverages, spending money, insurance, travel insurance, passports and visas (if applicable). For the avoidance of doubt, the winners and their Nominated Children must make their own way (at their own cost and responsibility) to the Event.

13. The Winner and their Nominated Child acknowledge that the prize may involve an activity, which may result in injury, and participate at their own risk.

14. No compensation will be payable if the winners and their Nominated Children are unable to participate in or use any element of the prize as stated for whatever reason, including refusal of participation in certain activities for health, age, behaviour or safety.

15. The winner and/or their Nominated Child must conduct themselves in a responsible, courteous and friendly manner at all times whilst participating in the prize. If a winner and/or their Nominated Children fail to participate in the prize in the manner required, as stated in this condition and in the reasonable opinion of the Promoter, their entry and the balance of the prize will be forfeited with no compensation payable.

16. The Prizes are transferable to another Nominated Child aged 6 – 12 (inclusive). A prize must be taken as offered and cannot be varied.

17. The winner and their Nominated Child indemnifies, and must defend and hold harmless, the Promoter and its employees, servants, agents and contractors, from and against all Losses arising from: a breach by the Winner and/or their Nominated Child of any of these Terms and Conditions; any third party claim arising directly or indirectly from a breach by Winner and/or their Nominated Child of any of these Terms and Conditions; a negligent, wilful or otherwise wrongful act or omission of Winner and/or their Nominated Child; fraudulent or dishonest acts or omissions by the Winner and/or their Nominated Child; any breach by the Winner and/or their Nominated Child of any applicable Laws; any claim by any third party (including individuals, legal entities and governmental departments or agencies) arising directly or indirectly as a result of the Winner accepting this prize; the death of, or personal injury to, any person or any damage to, or loss or destruction of, any real or tangible personal property, to the extent caused by any act or omission of the Winner and/or their Nominated Child.

18. As a condition of accepting the Prize, the Winner and their Nominated Child consents to, in the event they are a winner, the Promoter using the Entrant's entry, name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period of time without further notification, remuneration or compensation for the purpose of promoting, publicising or marketing the promotion (including any outcome), and/or promoting any products or services manufactured, distributed and/or supplied by the Promoter.

19. An entry and any copyright subsisting in an entry irrevocably becomes, at time of entry, the property of the Promoter. The Promoter collects personal information about an Entrant to include the Entrant in the promotion and, where appropriate, award prizes. If the personal information requested is not provided, the Entrant cannot participate in the promotion and is deemed ineligible. An Entrant also agrees that the Promoter may, in the event the Entrant is a winner, publish or cause to be published the Entrant winner's name, winning image and locality in any media.
