



## TERMS AND CONDITIONS

### CARLTON DRAUGHT FRONT BAR

1. Information on how to enter and the prizes form part of these conditions of entry. Participation in this competition is deemed acceptance of these terms and conditions.
2. The Promoter is Indian Pacific Limited (trading as West Coast Eagles Football Club) of Domain Stadium, Gate 12, 250 Roberts Road, Subiaco, WA, 6008. (ABN 31 009 178 894)(Promoter).
3. The promotion commences prior to each home qualifying game at Optus Stadium opening and closing at the following times (promotional period);
