- 3. The Offer commences Saturday 8th April 2017 12.00am AWST and expires Friday 30th June 2017 11.59pm AWST (Offer Period).
- 4. The Vehicle must be purchased and delivered during the Offer Period.
- 5. The Vehicle may only be subject to one Offer claim.
- 6. Limit of one Offer claim per member.

- (iii) A copy of the registration papers of the Vehicle purchased
- (iv) A signed copy of the contract of sale for the purchase of the Vehicle
- 10. The name of the Member must be identical to the name contained in the sale contract and will be verified with the selling Toyota Dealers Retail Delivery Receipt.
- 11. The Claim Form must be received by Toyota WA within 30 days of the date of purchase of the Vehicle. Toyota WA will not accept any claims or pay any Reward if the Claim Form is received after the 30 day purchase period. Receipt of the form will be acknowledged either by email, post or phone call to the Member.
