

## May 2019 | TERMS AND CONDITIONS Win Double Passes for an Adelaide Oval Roof Climb

- 1. Information on how to enter the "Adelaide Oval Roof Climb" promotion form part of these terms and conditions. By taking part in this promotion participants agree to be bound by these terms and conditions.
- The promotion commences at 9.00am on Friday the 10<sup>th</sup> May 2019 and closes at 12:00 pm on Monday the 20<sup>th</sup> May 2019. ("Promotion Period")
- 3. To enter the promotion you must complete the 'Adelaide Oval Roof Climb' online entry form. Only one entry per person is permitted.
- 4. Subsidiary companies, retailers and agencies of Bridgestone Australia Ltd, are ineligible for the "Adelaide Oval Roof Climb" promotion. Government, wholesale and fleet customers of Bridgestone Australia Ltd. are also ineligible.
