The successful applicant will manage all of Collingwood's major facilities, including the Holden Centre, the Glasshouse, Victoria Park and our Foundation Magpie Nest houses, whilst also playing an important role in our new developments and future projects.

From a facilities management perspective, the position will be responsible for the management of all of the Holden Centre/Glasshouse facilities, including that of the event spaces, theatre, eatery and gymnasiums, as well as assisting with the general upkeep of our grounds. You will arrange and maintain all cleaning, security, night patrol, general maintenance and waste removal contracts, whilst proactively working with relevant departments in regards to the club's procurement strategy and assisting with ensuring to engage the most effective supplier agreements.

Another important component of this role is relationship management and the responsibility of managing and liaising with external stakeholders, such as Melbourne & Olympic Parks Trust (MOPT) and the Big Group, as well as other sporting clubs within the precinct and relevant city councils. You will act as Chairperson of our Occupational Health & Safety Committee, as well as Chief Fire Warden and represent Collingwood at all MOPT precinct OH&S committee meetings.

Other responsibilities include:

- Management of the facilities and maintenance budgets for the Holden Centre, the Glasshouse and the CFC Community Centre
- Overseeing of the building management systems at the Holden Centre, Glasshouse and CFC Community Centre
- Management of the general repair and maintenance of the Foundation's Magpie Nest Houses
- Management and co-ordination of all trade representatives and contractors attending CFC facilities
- Liaise with the Big Group, for function booking requests, including for use of oval, Holden Centre rooms, car-parking passes etc.
- Liaise with Victoria Park tenants and Yarra City Council, as required, and regular attendance at Victoria Park tenant meetings
- Management of all CFC car parking at Olympic Park and Melbourne Arena, and main contact with MOPT regarding any car
  parking requests and/or issues
- Management and implementation of the club's Organisational Risk Management plan
- General upkeep of relevant first aid kits as well as main contact with St John for regular restocking
