'VARCODES' SCAVENGER HUNT

COMPETITION TERMS AND CONDITIONS

COMPETITION

- 1. This document contains the terms and conditions of entry ("these terms") into the Varcodes scavenger hunt competition ("Promotion"), information on how to enter the Promotion, and information about the prizes which form part of these terms. Entry into this Promotion is deemed acceptance of these terms. By entering this Promotion, the entrant acknowledges that they have read, understood and agree to be bound by and abide by these terms.
- 2. The promoter is Collingwood Football Club Limited (ABN 89 006 211 196) of Holden Centre, Cnr Olympic Blvd and Batman Ave, Melbourne VIC 3000 ("**Promoter**").
- 3. Subject to the Australian Consumer Law, the Promoter may vary the terms of, or terminate, this Promotion at any time at its absolute discretion without liability to any entrant or other person. The Promoter will not award any prize if the Promotion is terminated for whatever reason. If the Promotion is not capable of being conducted due to circumstances beyond the Promoter's control, including due to any technical or communications problems, the Promoter reserves the right to amend, suspend or cancel the Promotion.

DEFINITIONS

- 4. In these terms, the following meanings apply in addition to terms which are defined elsewhere in these terms unless the contrary intention appears:
- "Entrant" means a person who is eligible to participate in the promotion in accordance with clause 6 of these terms.
- "**Prize**" has the meaning in clause 13.
- "Winner" means the Entrant whose is selected from all Eligible Entrants during a Promotional Period.

PROMOTION PERIOD

5. The Promotional Period will be open from 11:30 am Australian Eastern Standard Time ("**AEST**") on Saturday 18 August 2018, and will continue until 1:45 PM (AEST) on Saturday 18 August, 2018. ("**Promotion Period**").

ELIGIBILITY

6. Entry is open to any person ("**Eligible Entrants**"), who attends Collingwood's round 22 match against Port Adelaide, excluding employees of the Promoter, and other agencies, firms or companies (and their immediate families), who are directly associated with this Promotion.

HOW TO PARTICIPATE

- 7. To participate in the Promotion and be eligible to win, an Entrant must:
- a. Personally witness five (5) 'Varcode' posters hidden in the Olympic Park precinct (including inside the Holden Centre) and surrounding area on Saturday 18 August, 2018. For example:

- c. Take a photo, or 'selfie', at each poster as proof, and make note of the unique code-word listed on each poster. The Entrant must ensure the location and/ or the match they are attending is clearly identifiable. The Entrant must seek permission from additional individuals that feature within the photo(s) submitted for the purposes of entry.
- d. Use the five (5) unique code-words to form a secret sentence which will unlock the prize. This sentence, in addition to five (5) photos must be shown at the Collingwood Membership Hub (MCG concourse, between gates 3 and 4) before 1.45pm on Saturday 18 August, 2018.
- 8. The first person to successfully reach the criteria above will be awarded the major prize. This is a game of skill, and there is no element of chance.
- 9. The decision of the Judges is final. No correspondence will be entered into.

CONDITIONS OF ENTRY

- 10. If an Entrant is the Winner, they must consent to and licence the recording and use of their name, character, voice, image and likeness by or on behalf of the Promoter for the purposes of any promotional, marketing or publicity activities by the Promoter. Any such use by, or on behalf of, the Promoter may occur without acknowledgment, remuneration or compensation to the Winner.

The Promoter accepts no responsibility for any variation in the value of the Prize. If for any reason, the Prize Winner cannot experience any component of the Prize as confirmed in writing, then that part of the Prize will be forfeited at the Promoter's discretion and the Promoter shall not be liable for any component forfeited.
