

‘Programmed Match Day Promotion’ – Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. By entering the competition, entrants agree to abide by these Terms and Conditions.
3. The Terms and Conditions of this competition are governed by the laws of the State of Western Australia.
4. The competition is being run by Fremantle Football club on behalf of Programmed Maintenance Services [Limited](#), 47 Burswood Road, Burswood, Western Australia, 6100 (“Programmed”).
5. The Programmed Match Day Promotion (“the competition”) commences at approx. 7.30pm Australian Western Standard Time (AWST) on Saturday 20 July 2019.
6. The closing time for entering the competition is approx. 7.30pm AWST on <Saturday 20 July 2019>.
7. Entry to the competition is limited to attendees of the Fremantle Dockers vs. Sydney Swans match at Optus Stadium, Perth.
8. To enter the competition, the entrant must:
 - (a) be present at the Fremantle Dockers Vs. Sydney Swans AFL match on Saturday, 20 July 2019; and
 - (b) be seated while competition is drawn
9. Entry to the competition is free.
10. Staff employed by Programmed and their immediate family members are not eligible to win the competition.
11. There will be one (1) prize. This prize will consist of;
 - 2 return economy flights to Florida, USA departing from Perth.
 - 5 nights’ accommodation at a suitable 4 star hotel within a 40 kilometre proximity of Kennedy Space Center.

13. If the chosen winner is not present at time of draw, a redraw will occur. Redraws will continue in the same manner until a winner has been chosen.
14. If the prize winner is under the age of 18 years, they must be accompanied by a parent or legal guardian to accept this prize.
15. The prize may be collected in person by the prize winner or parent/legal guardian or may be mailed/couriered.
