

# HBF Fremantle Dockers run-through banner Competition

## Terms and Conditions

### General

1. Instructions on how to enter and other details contained within promotional advertisements for the competition form part of the conditions of entry.
2. By entering the competition, entrants agree to abide by these terms and conditions.
3. Employees, contractors and agents of HBF and its related companies and their respective immediate families are ineligible to enter.

### Competition as a trade promotion lottery

4. The competition is a Trade Promotion Lottery, governed by the Gaming and Wagering Commission Act 1987 and Gaming and Wagering Commission Regulations 1988. The Gaming and Wagering Commission is the statutory body that administers these laws.
5. HBF as a promoter means HBF Health Limited ABN 11 126 884 786 carrying on business as HBF and under other business names.

### Prize details & conditions

6. Prize: One **(1)** competition winner (**Winner**) will receive two (2) public reserve tickets to the second home final (semi or preliminary final) that the Fremantle Dockers play in the 2015 Toyota AFL finals series at Domain Stadium. Their message will be placed on the banner that the players run-through prior to commencing the game. In addition this message will be featured on hand held banners that will be distributed amongst the crowd. Four (4) runners-up will receive two (2) public reserve tickets and their message will be featured on hand held banners that will be distributed amongst the crowd.
7. Five (5) prizes will be awarded.
8. All entrants must be over 12 years old.
9. The prize cannot be exchanged for cash.
10. The Fremantle Dockers and HBF reserve the right to change the wording, but keep the essence of the message the same, should the winner use wording that doesn't meet the Club's guidelines.
11. All other costs and expenses associated with the prize, beyond the specified prize components, will be the responsibility of the Winner.
12. The Winner will be responsible for any and all taxes incurred in relation to the receipt of the prize.
13. Substitute prizes will not be available, should the Winner be unable to use the prize at the allocated time.
14. HBF may at its absolute discretion substitute a different prize in place of any prize referred to in these terms and conditions.

### Competition duration

15. The competition will commence at 8AM WST on Saturday, 5 September (**Commencement Date**).
16. Entries for this competition will close at 12noon WST on Wednesday, 9 September (**Closing Date**).
17. No late entries will be eligible to enter the competition.

### Method of entry

20. The shortlist will be selected by the Fremantle Dockers and HBF by 8.30AM WST on Thursday 10 September.
21. The winner of the run-through banner will be selected based on the most number of likes on their comment at 12noon on Saturday 12 September.
22. In the event that there are two posts with the same amount of likes, the Fremantle Dockers will select the Winner from the two available options.
23. The runners-up will be the remaining shortlisted entries after the winner has been selected.
24. The judge's decision will at all times be final and no correspondence will be entered into.

#### **Winner notification**

25. The Winner will be notified by their social media account and/or handle.

#### **Publicity**

26. It is a condition of entry that HBF has the right to publicise the Winner for any promotion or matter incidental to the competition, if required.
27. The Winner may also be required by HBF to participate in a photo session and acknowledge that HBF has the right to use such publicity photos in any medium (including, without limitation, the Internet), and in any reasonable manner it deems fit.
28. The winner agrees to allow HBF and the Fremantle Dockers to utilise their entry (i.e. comment) for promotional purposes throughout the duration of the 2015 Toyota AFL Finals Series.
