## MEMBER ELECTED DIRECTORS 2014/2015 NOMINATION FORM - EXPLANATION PAPER

In accordance with the Constitution of Fremantle Football Club Limited an election will be held for one (1) position to the Board of Directors, results of which will be announced on Tuesday 25 November 2014. The position, to be awarded to the approved nominee with the highest number of votes received as declared by the Returning Officer, is for a term of two (2) years beginning 1 December 2014.

In the circumstance where there is only one (1) approved nominee, that person will automatically be elected to a two (2) year term. Nomination forms will be available from the Company Secretary of the Fremantle Football Club on application from 9 am on Tuesday 30 September 2014. Completed nomination forms must include:

- a nominator and four seconders who are financial Voting Club Members for a minimum of the past 5 consecutive years,
- a copy of the nominee's Birth Certificate or Extract of Entry,
- a Police Clearance not older than 12 months,
- a two page summary of the nominee's background and reasons why the nominee can make a valuable contribution to the Club, and
- a passport photo and 150 word statement about the nominee for distribution to Voting Club Members plus a declaration that this information can be publicly distributed for the purposes of the election.

Completed nomination forms must be lodged with the Company Secretary before 12 noon on Tuesday 14 October 2014 in the following manner:

- By Post to the Fremantle Football Club Ltd, PO Box 381, Fremantle, WA, 6959; or
- By Hand to the Fremantle Football Club Ltd, Fremantle Oval, Parry Street, Fremantle, WA, 6160; or
- By Facsimile to (08) 9433 7001.

Nominees are welcome to view the Constitution of the Club via appointment with the Company Secretary. All accepted nominees are required to meet with the club Board of Directors on Thursday 16 October 2014, to discuss their nomination and election protocols.

**ELIGIBILITY TO VOTE:** All Voting Club Members listed on the Club's register of Voting Club Members at 12 noon on 30 September 2014. Voting Club Members are Club Members, other than Associate Members who are:

- (a) a person, being 18 years of age or older, or
- (b) a body corporate which has purchased or been allocated one or more season ticket/s.

Each Voting Club Member is entitled to one (1) vote. A body corporate that is a Voting Club Member and has appointed an approved representative is entitled to one (1) vote.

**INTERNET VOTING PROCESS:** In circumstances where there is more than one (1) approved nominee, all Voting Club Members will be notified of such on Friday 24 October 2014 and able to vote from 9 am on Monday 3 November 2014. A letter including information on 'how to vote' together with a 'Notice of Annual Members' Meetings' will be sent to all Voting Club Members. Voting will be conducted on the Internet in a secure on-line facility. Voting Club Members may review the Candidate's summaries and vote on-line via a link from the Club's website to Computershare. If you are unable to submit your vote on-line, you will be provided with an alternative option within your mail pack.

**CLOSE OF VOTING – 5 pm Monday 24 November 2014:** All votes must be lodged (on-line) or received (Postal) by the Returning Officer no later than 5 pm on Monday 24 November 2014. Any votes received after this time will be considered late and therefore invalid.
