Conditions of Entry

1. The Club is (jointly and severally where applicable) Fremantle Football Club Limited (ABN 830 660 552 49)
2. Instructions and information on how to enter form part of these Conditions of Entry. Participation in this Promotion constitutes acceptance of these Conditions of Entry (and Schedule). Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.
3. All decisions and actions of the Club relating to the Promotion and/or redemption of the prizes are exercised accordingly at its absolute discretion and are final. No discussions or correspondence with entrants or any other person will be entered into.
4. If the Promotion is not capable of being conducted due to circumstances beyond the Club's control, including due to any technical or communications problems, the Club reserves the right to amend, suspend or cancel the Promotion subject to approval from any relevant authority.
5. The Club may (subject to State Regulations) vary the terms of, or terminate, this Promotion at any time at its absolute discretion without liability to any entrant, contestant or other person. The Club will not award the prize if the Promotion is terminated for whatever reason.
6. To enter the Promotion, entrants must complete the Entry Procedure and comply with all other applicable requirements during the Promotion Period. Eligibility to enter the Promotion is subject to the Entry Restrictions. The Promotion will be conducted during the Promotion Period.
7.
