## 2019 TOYOTA AFL GRAND FINAL PACKAGE

- 1. By entering into this lottery, you (Entrant) accept these terms and conditions.
- 2. The entity facilitating the draw is GCFC Ltd ABN 47 144 555 822 (**GCFC**) and the name of the lottery is the 'Gold Coast SUNS Foundation Match Day Raffle'.
