



### Terms and Conditions

## Tech Savvy Seniors Promotion

(August 14 2014 – August 25 2014)

1. Information on how to enter and the prizes form part of these conditions of entry. Participation in this competition is deemed acceptance of these terms and conditions.
2. The promotion commences at 9.00am AWST on Thursday August 14, 2014 and closes at 12pm midday AWST on **Monday, August 25**. (Promotion Period).

Participants must attend all six sessions to qualify for a course completion certificate.

  - WEEK 2: Basic introduction on how to use a computer.
  - WEEK 3: Internet Use – Club website, Email, Browsers, Security and Scams.
  - WEEK 4: Facebook introduction - How we can connect with our families and friends.
  - WEEK 5: Skype Introduction - How to make free local and international video calls.
  - WEEK 6: How to better connect with the West Coast Eagles, shop safely on-line and manage your membership preferences.
- 11.). The course is aimed at complete beginners and as such those people who have little or no experience with computers will benefit the most. Microsoft Office training is not included in the course content.
