

## WESTERN BULLDOGS – ROUND 14, WORKSAFE LOUNGE COMPETITION

### How to Enter

To be eligible to enter, you must visit the Western Bulldogs website, [www.westernbulldogs.com.au](http://www.westernbulldogs.com.au). To enter, you must complete your first name, surname, email address, a phone number (mobile),

and answer the question "In 25 words or less, what's your most important reason for coming home safely from work?"

There will be one winner during the Promotion Period. Entries will be judged based on the warmth, originality and creativity of the entrant's submission as determined by the Judges in their absolute discretion.

### TERMS AND CONDITIONS

2. Entry into the Promotion constitutes acknowledgement and acceptance of these terms and conditions. Information on how to enter, all entry instructions, advertising material and prize information published by the Promoter form part of these terms and conditions.
3. An Entrant is any person who has entered this Promotion in accordance with these terms and conditions. Entry is open to all Australian residents. Employees or directors of the Promoter, immediate family members of any employee or director of the Promoter, any retailer, supplier, associated company or agency of the Promoter and any person who the Promoter has previously notified are not eligible to enter.
