

## **“Essendon Football Club Gift with Purchase Pack” Terms & Conditions**

- 1) Information on how to enter the Promotion forms part of these terms and conditions of entry. Participation in this Promotion is deemed acceptance of these terms and conditions of entry.
- 2) This Promotion commences at 9:00am (AEST) on 13/03/2017 and concludes at 11:59pm (AEST) on 29/09/2017, or until a total of 200 Gift with Purchase packs have been successfully redeemed as per the Conditions set out below, whichever is earlier.
- 3) One (1) entry is permitted for every Eligible Product purchased during the Promotional Purchase Period. Entrants must submit a new entry with all requested details as listed in element b. below for every Eligible Product purchased. ### **HOW TO REDEEM**

## **ELIGIBILITY CONDITIONS AND REQUIREMENTS**

7. The Promotion is only open to Australian residents, who are also 2017 members of the Essendon Football Club, who purchase an Eligible Product within the Promotional Purchase Period.
8. Purchases must be from any Fujitsu retailer or dealer in Australia. Purchases must be made in the Entrant's name only.
9. Purchases must only be for domestic and residential use, and excludes non-residential applications.
10. Purchases by, for and in the name of trusts, companies, businesses, commercial or residential developers/developments and purchases by builders, subcontractors, installers/resellers and their immediate family are not eligible. The purchaser is considered as the payer of the Eligible Products as shown on the submitted proof of payment.
