

**Handball with Hankook**  
**Game of Skill Terms and Conditions**

1. Instructions, prizes and information on how to enter form part of these Terms and Conditions. By entering, entrants accept these Terms and Conditions. If you do not accept these conditions you must not enter.
2. The promoter is Essendon Football Club, 275 Melrose Drive, Melbourne Airport, VIC 3045. ABN 22 004 286 373.
3. The benefiting party is Hankook Tyre Australia Pty Ltd, Building A, Level 3, 11 Talavera Road, Macquarie Park, NSW 2113. ABN 77 082 389 704.
4. The promotion runs from 30 May 2018 to 11 August 2018 ("Promotional Period").
5. The promotion is open to residents of Australia, aged 18 years and over. Employees (and their immediate families) of the promoter, benefiting party and third parties associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step- grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
6. To be eligible to enter, individuals must, answer the question correctly posed on the Promoter's Twitter page.
7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. 8. Incomplete, indecipherable or illegible entries will be deemed invalid.
9. Multiple entries in the one Promotional Period are not permitted. To avoid doubt, entrants may enter the Promotion once in each of the Promotional Periods.
10. The selected participants of the Promotion shall be the first two people to answer the Handball with Hankook question correctly on the Promoters Twitter page. The Promotion is a game of skill.
11. The selected participants will be notified by Twitter message from the Essendon Football Club's Twitter account.
12. The selected participants as judged by the Promoter will each will have a chance to win the following. The individual prizes each consist of:
  - Two GA tickets to the corresponding match day that the activation will take place
  - Chance to participate in the 'Handball with Hankook' activation at ¼ time at each Essendon home game the week following the Twitter competition
  - Each selected participant will get the chance to handball AFL balls through a Hankook tyre stack for 20 seconds
  - The participant who gets the most handballs through the tyre in the 20 seconds will win a \$250 Eftpos gift card
13. The prize is valued AUD\$250. The prize is not transferable or exchangeable and cannot be taken as cash.
14. If the prize (or part of the prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
15. Entrants consent to the Promoter using their name, likeness, image, voice and/or social media posts content in the event they are the winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Promotion (including any

outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of the prize / attendance at the prize event.

The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. We may disclose this information to third parties who provide us with administrative services. This information will be stored at the office of the promoter. ### ***You indemnify us***

### ***Exclusions and our liability***
