

ESSENDON FC 'LOVE THE GAME' QUIZ
TERMS AND CONDITIONS

1. The Promoter of this competition is the Victorian Responsible Gambling Foundation.
2. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
3. Entry is only open to Victorian residents aged 18 years or over. Any individuals under the age of 18 may answer the quiz and participate in the competition with a parent as the formal entrant.
4. Individuals must have access to the internet to submit an entry.
5. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

 - b) Submit their name and contact details (and a parent's details if under 18) at the bottom of the quiz to go in the draw to win the prize

9. Multiple entries not permitted within the entry period.
10. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
