TERMS AND CONDITIONS

Entry restrictions	Entry is only open to residents of Victoria, Northern Territory, Queensland, South Australia, Tasmania and Western Australia aged 18 years or over. Residents of New South Wales and the Australian Capital Territory are not eligible to enter.
