

**“HAWKS FANS’ MVP” PROMOTION
TERMS AND CONDITIONS**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents who live in Victoria, aged 18 years or over. Individuals must have access to the internet and create an account with Hawks fans’ MVP (Most Valued Player).
3. Employees (and their Immediate Families) of the Promoter (Victorian Responsible Gambling Foundation) and agencies associated with this promotion are ineligible to enter. Immediate Family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

Prize draw

- a) Following the Hawks match, place your votes in the Hawthorn Fans' MVP at <https://fansmvp.afl.com.au/hawthornfc/vote/round>, if it's the entrant's first time voting registration must be completed;
- b) Assign three (3) votes to the player you deem to be the best Hawks player for that game, two (2) votes to the second best player and one (1) vote to the third best.
- c) Enter every week from Entry Period one (1) to Entry Period twenty two (22) to be in the draw for the prize draw.

6. Incomplete or indecipherable entries will be deemed invalid.

7. Multiple votes are not permitted within each Entry Period. One entry is required each week during Entry Period one (1) and Entry Period twenty two (22) to go in the draw for the prize.

The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
